#### 'BERTH' PANGS

#### Ten killed as trailer...

Last Saturday, 25 people were charred to death when the bus in which they were travelling caught fire on the Samruddhi Marg in Buldhana.

According to police, a 14-wheeler trailer coming from Indore reached Palasner village in Shirpur taluka on Tuesday, when its brakes failed, resulting in a collision with several vehicles and subsequent crashing into a dhaba.

The long rig first tossed into the air a person standing by a truck, then went on to hit a car, in which a woman and her three children were seated. They were crushed to death while the father of the children is battling for life in a nearby hospital.

After hitting the car and bus stand, the vehicle went further towards the village, hitting a bike and injuring both the bike riders. Going further, it tossed a few bikes parked outside Parmar Dhaba and then rammed into the eatery. Since it was morning, there were many customers in the hotel, who were also in-

A police officer said the container was barrelling down so rapidly that its front end crashed through the dhaba while its rear overturned. "There is a turn on the road where the accident happened, so we feel that the container driver was driving at a high speed which he could not control," said the officer.

Dhule Police said the container had a cargo of stones and the driver was coming at a high speed. Police are working

with experts to ascertain whether the reason for the accident was brake failure or speeding.

#### Disqualification 'ghost'

As per the plea, the constitutional requirement of fairness enjoins upon the Speaker the obligation to decide on the question of disqualification in an expeditious manner.

"Any unreasonable delay on the part of the Speaker in deciding the petitions for disqualification contributes to and perpetuates the constitutional sin of defection committed by the delinquent members ...," the plea has said.

This is the second time within months that the Indian Consulate in San Francisco came under attack from Khalistani supporters.

External Affairs Minister S Jaishankar on Monday said India has asked its partner countries such as Canada, the UK and the US not to give space to 'extremist Khalistani ideology" as it is "not good" for relations.

#### Taliban bans beauty salons

The letter, which was released just days after Akhundzada claimed that his government has taken steps for the betterment of women's lives in Afghanistan, doesn't give reasons for the ban.

The latest ban "will affect thousands of makeup artists and close hundreds of beauty shops nationwide", said Jamila Afghan, an Afghan women's rights activist who fled the country and now lives is Turkey, according to Bloomberg. "The Taliban don't consider women as human beings but as a commodity to own and oppress," she reportedly said.

Despite initial promises of a more moderate rule than during their previous stint in power in the 1990s, the Taliban have imposed harsh measures since seizing Afghanistan in August 2021 as US and NATO forces were pulling out.

They have barred women from public spaces, such as parks and gyms, and cracked down on media freedom. The measures have triggered a fierce interuproar, increasing the country's isolation at a time when its economy has collapsed and have worsened a humanitarian crisis.

#### If ED is not checked...

Salve, along with Senior Advocate Mukul Rohatgi, was representing the Bansals before the apex court.

Supreme Court judge, Justice KV Viswanathan had recused from hearing the matter last month.

Additional Solicitor General SV Raju appearing for the ED, informed the bench that it would challenge the order passed in another case granting the brothers interim protection from arrest, once it comes up before the Delhi High Court on Wednesday.
