Sub: Update on Acquisition

Ref: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to the provisions of Regulation 30 of the Listing Regulations and with reference to the captioned subject and further to our letters dated February 29, 2024 and March 1, 2024, we hereby inform that the Company has on March 1, 2024 completed execution of the Deed of Assignment and Deed of Retirement with respect to the acquisition of Ayushi and Poonam Estates LLP.

The existing partners have assigned their capital and profit in Ayushi and Poonam Estates LLP to Chalet Hotels Limited (CHL) and Sonmil Industries Private Limited (SIPL), as a result of which CHL and SIPL (wholly owned subsidiary of CHL) own 100% of the capital and 100% of the profit.

Payment of the consideration of Rs.3,150 Million (Enterprise Value), adjusted for Net Current Assets including cash, has been completed and existing partners have retired from Ayushi and Poonam Estates LLP. No further payouts are due to them.

Brief details of 'Courtyard By Marriott, Aravali Resort' are enclosed herewith.
